For the 2026 Annual General Meeting of Shareholders

Premier Quality Starch Public Company Limited (“Company”) We would like to inform the personal data protection information in accordance with this Announcement in order to comply with To comply with the Personal Data Protection Act (PDPA) B.E. 2562 (2019) As follows:

1. Personal Information Collected

The Company will collect and process your Personal Data. Whether it is personal data that you provide directly to the Company or personal data that the Company receives from Thailand Securities Depository Co., Ltd. (TSD) as the Company's securities registrar, including but not limited to the following information:

- General personal information, such as name-Full name, date of birth, age, address Telephone number, fax number, email, ID card number Passport number Shareholder Registration Number Number Type of shares held, etc.
- Financial information to process the benefits of shareholders, such as bank account number, bank name, cheque number, etc.
- Photos and videos from video recordings at the shareholders' meeting, including computer traffic data generated from the registration to attend the meeting and/or recorded during the meeting.
- Information that you have provided through the investor relations channels on the Company's website or through other channels specified by the Company.

The Company does not intend to collect and process Sensitive Personal Data (Sensitive Data) as follows: Your religion and blood type information (if any) which appears on the identification documents submitted by you and/or your agent to the Company. If the Company receives such information in any case, it will conceal the information on those documents and shall not be deemed to have collected and processed such information in any way.

2. Purpose, Legal Basis and Disclosure of Personal Data

The Company is required to collect, process and disclose your Personal Data for use under the following purposes and legal bases:

- Contract for the necessity of complying with the Company's Articles of Association or any agreement that the Company has with you as a shareholder.
- Legal obligation for the conduct of shareholders' meetings (e.g. proposal of agendas, delivery of documents, registration, etc.). Voting processing), preparation and dissemination of meeting minutes. Actions related to the payment of dividends or any other benefits, including to comply with court orders, government agencies, or relevant regulatory agencies

such as the Department of Business Development, the Securities and Exchange Commission (SEC), or The Stock Exchange of Thailand, etc.

- Legitimate Interests for the recording of photos and videos at the shareholders' meeting to prepare publicity materials or minutes of the meeting, as well as security management within the event premises, organizing the Company's activities, and communicating through investor relations channels.
- Consent in the event that the Company needs to collect Sensitive Data other than those specified in Clause 1. or where consent is required by law. The Company will ask for your explicit consent before proceeding.

To achieve the above objectives. The Company may disclose your Personal Data to third parties, such as Thailand Securities Depository Company Limited (TSD), banks or financial institutions. Service providers to companies (e.g., publishing and delivery service providers, conferencing service providers), as well as courts, government agencies, or regulatory authorities as required by law.

However, Where the collection and processing of your personal data is based on compliance with the law or contract. If you are unable to submit the required personal data, you will be able to submit the required personal data. The Company may not be able to implement the benefits that you are entitled to as a shareholder.

3. Retention Period of Personal Data

The Company will retain your Personal Data for the duration of your status as a shareholder of the Company and will continue to retain such information for a period of 10 years from the date you cease to be a shareholder or for the period of time prescribed by relevant laws. Upon the expiration of such period, the Company will delete, destroy or anonymize the information.

4. Rights of Data Subjects

Under the rules set out in the Personal Data Protection Act B.E. 2562 (2019), you, as a data subject, have the following rights:

- The right to request access, obtain a copy of, or request disclosure of the acquisition of personal data.
- The right to request the Company to correct the Personal Data to be accurate, complete and up-to-date.
- The right to request the Company to send or transfer personal data to another data controller.
- Right to object to the collection, use or disclosure of personal data
- The right to request the restriction of the use of personal data.

- The right to request that the Company delete, destroy or anonymize personal information.
- The right to withdraw consent (where the processing is based on consent)
- The right to lodge a complaint with the Personal Data Protection Committee If the company violates or does not comply with the law,

In the event that you, as a data subject, submit an application to exercise your rights under the provisions of the Personal Data Protection Act (PDPA) B.E. 2562 (2019). The Company will complete the request within 30 Days from the date of receipt of the request However, the Company will consider various factors to consider your request, and the Company may reserve the right not to comply with your request to exercise your rights as required by the Personal Data Protection Law.
